16. 2.1 MINIMUM CRITERION FOR BID: (Pg No. 11) to be read as follows.

The bidders meeting the following minimum criteria shall be eligible to submit the bids with documentary evidence.–

- a) The Bidder should be in the business of Dietary Services for atleast 5 years i.e. 2012-13, 13-14, 14-15, 15-16 & 16-17 and also still continuing in that business in any hospital/ Govt. Educational Institutions/ Reputed Educational Institutions.
- b) The Bidder should have satisfactory performance certificate from the concerned institution where the services have been provided.
- c) The Bidder should have experience in providing Dietary Services of serving atleast 700 persons per day in any one of the places like hospital/ Govt. Educational Institutions/ Reputed Educational Institutions.
- d) The Bidder should have experience of installing Kitchen Equipment worth atleast Rs.20.00 lakh for setting up Kitchen in any of the hospitals/ Govt. Educational Institutions/ Reputed Educational Institutions etc.
- e) The bidder should have atleast total annual turnover of Rs.6.00 crores in last three years i.e. 2014-15, 15-16 & 16-17, out of which the annual turnover should not be less than Rs.1.5 crores in any two years.
- f) Bidder must have GST registration.
- g) The Bidder should have valid labour license and trade license. (Those who do not posses such license for Bhubaneswar jurisdiction, shall have to provide the same within 1(one) month of receiving the Award of Contract.
- h) Bidder should have registration with ESI &PF.
- i) Bidder should also have ISO Certificate and FSSAI License as per FSS Act, 2006.
