TERMS & CONDITIONS FOR CONTRACT APPOINTMENT FOR NON-FACULTY

POSTS:

1. The Appointment is purely on CONTRACT BASIS for a period of 11 months or till such time the regular appointments against these vacant posts are made, whichever is earlier, with effect from the date of joining. If the contract is not extended further, the same will automatically lapse. The appointment may also be terminated at any time by either party with one month's notice or payment of one month's salary in lieu of notice, without assigning any reason, or failure to complete the period of three months to the satisfaction of the Competent Authority.
2. The consolidated monthly remuneration for the post of Medical Physicist (Nuclear Medicine) is ₹ 86,955/-
3. The appointee shall perform the duties as assigned to him/her. The competent authority reserves the right to allocate additional duty as and when required. No extra/additional allowances will be provided for such assignments.
4. The appointee shall not be entitled to benefits such as Provident Fund, Pension, Gratuity, Medical Attendance Treatment, Seniority, Promotion, or any other privileges granted to regular government employees.
5. This appointment does not grant any claim or right for regular appointment to any post at AIIMS Bhubaneswar.
6. The appointee shall be on the whole-time appointment of the AIIMS Bhubaneswar and shall not accept any other assignment, paid or otherwise and shall not engage himself/herself in a private practice of any kind during the period of contract.
7. Appointment is subject to medical fitness certification by the designated Medical Authority.
8. Leave entitlement of the appointee shall be governed in terms of instructions issued by the DoPT or Institute's own rules and regulation as applicable.
9. Upon appointment, the candidate will be required to take an Oath of Allegiance to the Constitution of India or make a solemn affirmation to that effect in the prescribed proforma.
10. The appointee will not be entitled to Travel Allowance (TA) for attending the interview or for joining the Appointment.
11. No allowances or facilities provided to regular/permanent employees of AIIMS Bhubaneswar shall be applicable to the appointee.

12. Other service conditions will be governed by the relevant rules and regulations issued from time to time.
13. Interested candidates may apply for the post under reference in the prescribed Application Form available in the Institute website by attaching therewith the copies of self-attested Certificates/testimonials and other relevant documents etc. and to bring at the time of the walk-in interview.
14. If any declaration or information provided by the appointee is found to be false or misleading, or if any material information is deliberately suppressed, the appointee will be liable for termination of service and any other action deemed necessary by the Competent Authority.

16. AIIMS Bhubaneswar reserves the right to increase or decrease the number of vacancies.
