The Director, AIIMS Bhubaneswar, invites E-Bids in Two Bid System (i.e. Technical and Financial Bid) from eligible Manufacturers / Firms / Companies / Authorized Agents / Distributors / Dealers online through E-procurement solution portal of AIIMS Bhubaneswar (https://eprocure.gov.in/eprocure/app) as per terms and conditions contained in this document for satisfactory performance for Supply, Installation, Commissioning and Maintaining 02 Units of Fully Automatic Biochemistry Analyzers on Reagent Rental Basis for Dept. of Biochemistry at AIIMS, Bhubaneswar for a period of Five years from Letter of Award.

The Bidder is expected to examine all instructions, forms, terms and specifications in the bidding document. The bid should be precise, complete and in the prescribed format as per the requirement of the bid document. The bid should not be conditional. Therefore, bidders who are claiming to be regulated under the said order are to submit documentary evidence in support of their claim.

# **INSTRUCTIONS TO BIDDERS (ITB)**

- 1.1 The Bidders must go through the complete Tender Document for details before submission of their Bids. The bid submitted by Bidder and all subsequent correspondence and documents relating to the bid exchanged between Bidder and the Procuring Entity shall be written in English or the Official Language. However, the language of any printed literature furnished by Bidder in connection with its bid may be written in any other language provided a translation accompanies the same in the bid language. For purposes of interpretation of the bid, translation in the language of the bid shall prevail. Instructions to Bidders shall form part of this bid document and consequent contract out of this bid.
- 1.2 The Bidder shall bear all costs associated with the preparation and submission of its bid and AIIMS, Bhubaneswar will in no case be held responsible or liable for these costs, regardless of the conduct or outcome of the bidding process.
- 1.3 Bid Validity: The validity of the Bid/ Tender Document shall be 180 DAYS from the date of opening of the bid.
- 1.4 Bidder's Eligibility: Tender should be quoted only by the original manufacturer (OEM) or by their Authorized Distributor or Selling Agent. Bidder other than OEM shall submit a current authority letter from the original manufacturer concerned in the format given at "Annexure-III".
- 1.4.1 The bidder must be a natural person, private entity or public entity (State-owned enterprise or institution).
- 1.4.2 The bidder must not be a Joint Venture/ Consortium (an association of several persons, firms, or companies- hereinafter referred to as JV/C).
- 1.4.3 The bidder must not be insolvent, in receivership, bankrupt or being wound up, not have its affairs administered by a court or a judicial officer, not have its business activities suspended and must not be the subject of legal proceedings for any of these reasons.
- 1.4.4 The bidder must not be convicted (within three years preceding the last date of bid submission) or stand declared ineligible/ suspended/ blacklisted/ banned/ debarred by appropriate agencies of Government of India from participation in Tender Processes of all of its entities.
- 1.4.5 The bidder must not be of the near relations of executive of Procuring Entity involved in this Tender Process.
- 1.4.6 Any bidder having a conflict of interest, which substantially affects fair competition, shall not be eligible to bid in this tender. Bids found to have a conflict of interest shall be rejected as non-responsive.
- 1.4.7 Any bidder (as defined in paragraph 6 of the Order No. F. No. 6/18/2019-PPD dated 23.07.2020 issued by Ministry of Finance Department of Expenditure Public Procurement Division) from a country which shares a **land border with India** will be eligible to bid in this tender if the bidder is registered with the Competent Authority as prescribed in the aforesaid order. Proof of such registration should be enclosed with the bid documents.
- 1.4.8 In case **where the manufacturer has submitted the bid**, the bids of its authorized dealer will not be considered and EMD will be returned.
- 1.4.9 Any bidder (as defined in paragraph 6 of the Order No. F.No. 6/18/2019-PPD dated 23.07.2020 issued by Ministry of Finance Department of Expenditure Public Procurement Division) from a country

which shares a land border with India will be eligible to bid in this tender if the bidder is registered with the Competent Authority as prescribed in the aforesaid order. Proof of such registration should be enclosed with the bid documents. In case where the manufacturer has submitted the bid, the bids of its authorized dealer will not be considered and EMD will be returned.

- 1.4.10 **OEM Turn Over Criteria**: The minimum average annual financial turnover of the OEM of the offered product during the last three years, ending on 31st March of the previous financial year, should be **Rs. 4,00,00,000.00 (Rupees Four Crores only).** Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the OEM is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.
- 1.4.11 **Bidder Turn Over Criteria**: The minimum average annual financial turnover of the Bidder of the offered product during the last three years, ending on 31st March of the previous financial year, should be **Rs. 2,00,00,000.00 (Rupees Two Crores only).** Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the Bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.
- 1.4.12 **Experience Criteria**: Supportive document for a minimum of three installations in Govt. institutions within the last three years of satisfactory performance for the quoted equipment has to be provided by the vendor/bidder.
- 1.4.13 If the bidder is a Micro or Small Enterprise as per latest definitions **under MSME rules**, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to meeting of quality and technical specifications. If the bidder is OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. In case any bidder is seeking exemption from Turnover / Experience Criteria, the supporting documents to prove his eligibility for exemption must be uploaded for evaluation by the buyer. This Policy is meant for procurement of only goods produced and services rendered by MSEs. Traders/ distributors/ sole agent/ Works Contract are excluded from the purview of the policy.
- 1.4.14 If the bidder is a **Start-up**, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to their meeting of quality and technical specifications. If the bidder is OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. In case any bidder is seeking exemption from Turnover / Experience Criteria, the supporting documents to prove his eligibility for exemption must be uploaded for evaluation by the buyer.
- 1.5 Bidders are required to quote strictly as per specification of the equipment/ instruments/ apparatus. Deviation, if any to specification, must be brought out clearly giving deviation statement in Annexure-IV on or before the last date of submission of Representation.

**Exemption from EMD:** Following categories of Sellers shall however, be exempted from furnishing Bid Security:

- 1.6.1 Firms registered with **NSIC** (for sale of Medical Equipment/Instrument/ Apparatus) are exempted from submission of EMD (subject to the financial limits indicated in the NSIC certificate). Govt. of India/State Government departments/Undertakings are also exempted from EMD. However, the respective departments/ firms have to submit the relevant certificate (NSIC etc.) and financial limit to avail this exemption.
- 1.6.2 **Micro and Small Enterprises (MSEs)** who are holding valid Udyam Registration and are manufacturer of the offered Product or Service (Primary Product / Service in case of bunch bid with total value wise evaluation) and give specific confirmation to this effect at the time of bid submission and claim EMD exemption and whose credentials are validated online through Udyam Registration website of Ministry of MSME and also through supporting document uploaded during bidding process and validated by the Buyer. Under MSE category, only manufacturers for goods and Service Providers for Services are eligible for exemption from EMD. Traders are excluded from the purview of this Policy.
- 1.6.3 **Start-ups** as recognized by Department for Promotion of Industry and Internal Trade (DPIIT), holding valid Start-up Recognition Certificate which is to be uploaded while bidding and claiming EMD exemption and to be validated by the Buyer. Bidder to ensure that turnover for any of the financial years has not exceeded beyond limits prescribed in the certificate / Start Up scheme of DPIIT.

# 1.7 Clarification of bidding documents:

The Tender Inviting Authority shall not be responsible for individually informing the prospective bidders for any notices published related to this bid. Bidders are requested to browse e-Tender portal or website of the Tender Inviting Authority for information/general notices/amendments to bid document etc. on a day to day basis till the bid is concluded before submission of bid.

# 1.8 Amendments in Bidding Documents:

(i) At any time prior to the dead line for submission of Bid, the Tender Inviting Authority may, for any reason, modify the bid document by amendment and publish it in e-tender portal and AIIMS, Bhubaneswar website.

- (ii) At any time till 02 (Two) days before the deadline for submission of bids, the AIIMS, Bhubaneswar may, for any reason, whether at own initiative or in response to a clarification requested by a prospective bidder, modify through amendment. All amendments will be uploaded on the website regularly. AIIMS, Bhubaneswar shall not be responsible to notify the amendments to individual bidders. All amendments by the AIIMS, Bhubaneswar till 02 (Two) days before the deadline for submission of bids, shall be binding on the participatory bidders.
- 1.9 Terms of Two Bid System: The Tender shall be submitted in 02 (Two) Parts On-line:
- 1.9.1 **Technical Bid:** All required documents to be submitted online.
- 1.9.2 **Financial Bid:** Financial Bid is to be submitted on-line. The Financial Bid of bidders, who qualify at Technical Bid Evaluation, will be opened thereafter. While submitting Financial Bid following points need to be taken care of by the bidder.
  - 1.9.2.1 The Rates are to be quoted in the given format as per Annexure-VI & VII.
  - 1.9.2.2 All quoted rates should be inclusive of packaging & forwarding charges, insurance charges & freight (transportation) charges, other incidental charges and GST (percentage of GST must be mentioned clearly).
  - 1.9.2.3 Equipment shall be supplied & installed **FREE OF COST** at AIIMS, Bhubaneswar with 05 (Five) Year (or till the completion of the Contract) Comprehensive On-Site Warranty inclusive of all spares & labour charges and no extra cost to the Institute with this regard. If the Contract is extended, then additional On-site Warranty as deemed fit need to be arranged by the supplier. The bidder would be responsible for equipment repair and maintenance throughout the contract period.
  - 1.9.2.4 The rates should be quoted in Indian Rupees in figures as well as in words.
  - 1.9.2.5 If a firm quotes NIL charges/ consideration, the bid shall be treated as unresponsive and will not be considered.
  - 1.9.2.6 After due evaluation of the bids, Institute will award the contract to the responsive Bidder who has quoted the Lowest cumulative annual Cost of all Tests of all the parameters as per financial bid (Part-I), subject to MII preference clause. Taxes has to be mentioned clearly in percentage.
  - 1.9.2.7 Consumable Prices quoted by Bidder shall remain firm and fixed during the currency of the contract and not subject to variation on any account.
  - 1.9.2.8 **For evaluation of price bid to decide L-1, the cumulative annual Cost of all Tests** of all the parameters as per financial bid (Part-I) will be the deciding factor. The quoted costs should be including all cost associated towards the test.
  - 1.9.2.9 The Annual Test Load/total number of donation is approximate. The mentioned number of tests in the financial bid is only for comparative purpose for price bid evaluation. The department reserves the right to carry out and pay for decreased/increased number of tests.

- b. Undertaking for acceptance of all Terms & Conditions as per Annexure-I.

c. Notarized affidavit on Indian Non-judicial stamp paper of Rs. 10/- as per Annexure-II

### 1.10 Withdrawal, Substitution and Modification of Tender:

No bid will be allowed to withdrawn in the interval between the deadline for submission of bids and expiration of the period of validity. Withdrawal of a bid during this period will result in forfeiture of the bidder's bid security (EMD).

### 1.11 Public Procurement (Preference to Make in India/MSEs/Start-ups):

1.11.1 **Preference to Make in India products** (For bids < 200 Crore): Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. In case the bid value is more than Rs 10 Crore, the declaration relating to percentage of local content shall be certified by the statutory auditor or cost auditor, if the OEM is a company and by a practicing cost accountant or a chartered accountant for OEMs other than companies as per the Public Procurement (preference to Make-in -India) order 2017 dated 04.06.2020.

All Classes of suppliers are eligible to participate in the Tender as per OM No.-F.4/1/2023-PPD(Pt.) dated 28/06/2024. Eligible micro and small enterprises will also be allowed to participate.

Local content in the context of this policy is the total value of the item procured (excluding net domestic indirect taxes) minus the value of imported content in the item (including all customs duties) as a proportion of the total value, in percent.:

- a) 'Class-I Local Supplier' with local content equal to or more than 50%.
- b) 'Class-II Local Supplier' with local content more than 25%, but less than 50%.
- c) 'Non Local Supplier' with local content less than or equal to 25%.

Bids with false declarations regarding Local contents shall be rejected as unresponsive, in addition to punitive actions under the MII orders and for violating the Code of Integrity as per the Tender Document.

If a Bidder is claiming exemption (as obtained from relevant authorities) from meeting the stipulated local content on account of manufacturing the product in India under a license from a foreign manufacturer with the precise phasing of increase in local content, he must provide proof thereof

1.11.2 Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference, the bidder must be the manufacturer of the offered product in case of bid for supply of goods. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service. If L-1 is not an MSE and MSE Seller (s) has/have quoted price within L-1+ 15% (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such Seller shall be given opportunity

to match L-1 price and contract will be awarded for 25%(selected by Buyer) percentage of total QUANTITY.

1.11.3 **Concurrent application** of Public Procurement Policy for Micro and Small Enterprises Order 2012 and Preference to Make in India in Public procurement will be as per the guidelines laid down by the OM No.F.1/4/2021-PPD dated 18.05.2023 issued by Department of Expenditure amended from time to time. The OM is accessible through the following URL.

### 1.12 Procurement outside GeM:

As per the Circular No. F.6/18/2019-PPD issued by Ministry of Finance, Dept. of Expenditure dated 23 Jan 20 and DO No.214/CEO-GeM/2020 dated 10.11.2020 regarding procurement of goods/services outside GeM, bidders are required to submit documents in support of their registration with GeM i.e., Unique GeM Seller Id. with their bid. However, the bidder who is not registered with GeM at the time of submitting the tender needs to submit an undertaking on firm's letter head that GeM Seller Id. will be provided at the time of award of contract positively failing which their contract will be treated as null & void and will be dealt suitably.

An undertaking also to be given in company letter head that "Such already registered suppliers should be boarded on GeM as and when the item or service gets listed on GeM".

# 1.13 **Bid Opening:**

The Technical Bid will be opened as per schedule mentioned in E-Tender Schedule. The bidder(s) or their authorized representative(s) may remain present at the scheduled date and time. In case the scheduled date is declared Holiday, the tender shall be opened on next working day at the same time.

### 2. GENERAL TERMS AND CONDITIONS:

- 2.1 The Validity of the Bid/Tender Document shall be for 180 Days from the Date of Opening of the Bid.
- 2.2 Tenders should be quoted only by the Original Manufacturer (OEM) or their authorized distributor or selling agent, who shall submit a current authority letter in support of the same from the Original Manufacturer (OEM) concerned in the format given at "Annexure-III".

Bidders are required to quote strictly as per specifications of the Equipment/ Instruments/ Apparatus/Consumables. Deviation, if any to specification, must be brought out clearly giving deviation statement as per "Annexure-IV" on or before the last date of Representation.

Additional features if any, should be listed separately in the offer.

2.3 The model of the equipment offered should be brand new and should not be refurbished or obsolete, out of production for at least 10 years from the date of installation and commissioning of the Equipment.

The Chemicals, reagents and consumables to be supplied for running the equipment should have a life span of at least 01 year or 75% before the date of expiry whichever is more from the date of supply. Following text shall be printed or stamped in inedible ink on label/ pack/ cartons. "Not for Sale, For Use by AIIMS, Bhubaneswar Only."

# 2.4 Scope of Contract:

- 2.4.1 The Equipment/ Accessories/ Consumable supplied to the buyer under this contract shall be of the best quality and workmanship and shall be strictly in accordance with the specifications and particulars contained/ mentioned in the clauses hereof. The purchaser will be entitled to reject the said Equipment/ Accessories/ Apparatus/ Articles or such portion thereof as may be discovered not to conform to the said description and quality.
- 2.4.2 The supplier shall supply, install, commission and maintain the Equipment/ Consumables/ Control/ Calibrator free of cost and supply the required Chemical/Reagents will be procured as and when required on Reagent/chemical rental basis for satisfactory testing of all the testing parameters for a period of Five years. The reagent shall be provided free of cost for run failure, invalid QC/invalid Test.
- 2.4.3 Supplier shall provide one dedicated person contact for hands on training and to address maintenance or any other issue arises during operation of equipment.
- 2.4.4 The supplier shall have to undertake the shifting of the instrument from the location of installation to another location within the premises of department as and when required by the hospital authority.
- 2.4.5 The supplier should provide calibration report of the equipment as per OEM guidelines twice in a year. In case of doubt/conflict in the accuracy of the results, calibration report shall have to be submitted through third party NABL accredited competent agencies on request of the HOD of the department.
- 2.4.6 The functionality and efficacy of the equipment throughout the contract period is the sole responsibility of the successful bidder. The institute will not pay anything towards repair & maintenance of the equipment during the contract period.
- 2.4.7 Any up-gradation of device of the equipment or software update required for the optimum performance of the equipment shall be done by the supplier without any additional cost.

- 2.4.8 The firm will lift the equipment (as the condition may be) from the hospital site at its own cost within 15 days after expiry/termination of the contract without claiming any cost.
- 2.4.9 Contract may be terminated at any time without any prior notice if service of tenderer not found satisfactory.
- 2.4.10 Ownership status of all movable assets created from the investments made by the Service Provider shall remain with the Service Provider.
- 2.4.11 The Supplier shall not be entitled to levy any charge to the patients.
- 2.5 The Bidder should state categorically whether they have fully trained technical staff for installation/commissioning of the Equipment and efficient after sales services.
- 2.6 Deleted.
- 2.7 **Sixty-two Months On-Site Warranty including Spare Parts & Labour etc**. for main Equipment:
- 2.7.1 The Bidder will submit a written Warranty/ Guarantee from the manufacturer for 62 (Sixty-two) months On-Site Warranty including Spare Parts & Labour etc. for trouble free functioning and maintenance of the facility from the date of installation & commissioning absolutely at no extra cost to the institute. It should ensure that the equipment being offered is the latest model as per the specifications and the spares for the equipment will be available for a period of at least 2 years after the warranty / guarantee period of Five Years.
- 2.7.2 The supplier will guarantee One visit of Technical Support Staff every three months (4 visits in a year) for periodic/ preventive maintenance and any time for attending repairs/ breakdown calls.
- 2.7.3 The manufacturer should also give warranty/guarantee that will keep the institute informed of any up-date of the equipment over a period of next 05 years from the date of Installation & Commissioning of the equipment and undertake to provide the same to the institute at no extra cost.
- 2.7.4 The supplier further warrants that the items/Stores supplied under the contract shall have no defect arising from design, materials (except when the design adopted and/ or the material used are as per the AIIMS, Bhubaneswar specifications) or workmanship or from any act or omission of the supplier that may develop under normal use of the supplied Equipment under the conditions prevailing in India.
- 2.7.5 Under no circumstances the Institute will be allowed to suffer/ fail to provide required services by way of undue delay in repair/ rectification of defects in equipment by the vendor. Replacement and repair will be undertaken for the defective Equipment at no extra cost. Proper marking has to be made for all spares for identification. If at any time the equipment is beyond repair at its installation location and needs to be taken to vendor's Authorized Service Centre for repair, a backup/ stand by equipment must be provided subject to other administrative formalities.

Replacement will be undertaken for the defective Reagents/ Chemicals/ Consumables at no extra cost. Proper marking has to be made for all items for identification.

- 2.7.6 Conditional warranty like mishandling, manufacturing defects etc. is not acceptable.
- 2.8 Uptime Guarantee & Downtime Penalty Clause:

- 2.8.1 The firm will be required to guarantee that the equipment including the accessories will be maintained in good working condition for a period of 347 days out of a period of 365 days (i.e. 95% uptime on yearly basis throughout the warranty period as well as during the service contract period).
- 2.8.2 If the equipment is out of order for more than 05 hours during any day it shall be considered as one day down time. The essential period to shut down the installation entirely or partially should also be included in the down time if it exceeds 02 days while calculating the 95% guaranteed uptime.
- 2.8.3 Upon receipt of notice from the buyer, the supplier shall, within 48 hours on a 24 X 7 X 365 basis respond to take action to repair or replace the defective Equipment/Accessories or parts thereof, free of cost, at the ultimate destination. The supplier shall take over the replaced parts/accessories/stores after providing their replacements and no claim, whatsoever shall lie on the purchaser for such replaced parts/accessories/stores thereafter. The penalty clause for non-replacement will be applicable as per tender conditions.
- 2.8.4 If the supplier, having been notified, fails to respond to take action to replace the defect(s) within 48 hours on a 24 X 7 X 365 basis, the purchaser may proceed to take such remedial action(s) as deemed fit by the purchaser, at the risk and expense of the supplier and without prejudice to other contractual rights and remedies, which the purchaser may have against the supplier.
- 2.8.5 The firm will be required to pay a penalty of Rs. 500/- (Rupees Five Hundred only) per day for per unit in case the number of days of down time in each period of 365 days is more than the downtime permissible which is to be calculated as defined above and the delay for not bringing the equipment in functioning order is in any way directly, even partially, attributable to the supplier OR the warranty period will be extended double the down time by the vendor for every day of delay occurred.
- 2.9 The Supplier along with its Indian Agent shall ensure continued supply of the reagents, chemicals, consumables, spare parts for the machine(s) and Equipment to the purchaser during the Contract Period.
- 2.10 Fall Clause: If at any time during the execution of the contract, the Manufacture/ Distributor/ Dealer reduces the sale price or sells or offers to sell such stores/items, as are covered under the contract, to any person/organization including the purchaser or any department of Central Government or any department of AIIMS, Bhubaneswar/ other INI/ PSUs at a price lower than the price chargeable under the contract during the Currency of the contract, they will forthwith notify AIIMS, Bhubaneswar. The difference in cost due to such reduction or sale or offer of sale would be refunded by the bidder to AIIMS Bhubaneswar, if the contract has already been concluded or AIIMS Bhubaneswar will deduct from the pending bills/Performance Security Deposit to recover the loss to the Government.

# 2.11 **DELIVERY OF THE GOODS**:

- 2.11.1 The Delivery of Equipment/ Instruments/ Accessories/ Apparatus/ Consumables/ Chemicals/ Reagents should be made in good condition at the Central Stores, AIIMS, Bhubaneswar campus or place indicated in the Supply Order by the bidder at their own cost. AIIMS Bhubaneswar is not liable for payments on account of Packing & Forwarding charges, Freight, Insurance and other incidental charges.
- 2.11.2 The firm will be bound to supply the Chemicals, reagents & consumables within 30 (Thirty) days from the date of Purchase Order/ Supply Order and thereafter suitable action as deemed fit, will be initiated. The institute will recover the general damages or extra expenditure incurred in the risk purchase at the risk and cost of bidder and amount paid in excess shall be deducted from their pending bills. The above shall be in addition to forfeiture of Bid Security and black listing of the firm depending upon the circumstances of the default/ merit of the case.
- 2.11.3 If the supplier fails to deliver the goods on or before the stipulated date, then Liquidated Damage at the rate of 0.5% per week or part there of shall be levied subject to maximum of 10% of the total

order value. (Excluding the date of issue of Supply Order / acceptance letter and date of delivery). Purchaser may also resort to termination of the Supply Order & even Tender at any time after expiry of the allowable period for supply of the materials.

- 2.11.4 Part/Partial supply will not be accepted. For any part/ partial supply, the total quantity should be completed within given delivery period. However, Part Billing is strictly prohibited.
- 2.11.5 The firm shall supply the equipment/ consumables/ reagents/ chemicals with proper packing and marking for transit so as to be received at destination free from any loss or damage.
- 2.11.6 The equipment/ consumables/ reagents/ chemicals should be adequately covered under transit insurance at the risk and cost of the bidder.
- 2.12 Option clause: The purchaser reserves the right to place orders for additional quantity up to 25-30% of the originally contracted quantity at any time at the same rate and terms of the contract during the currency of the contract.
- 2.13 The Director, AIIMS Bhubaneswar has full authority to take into account the performance of manufacturer/authorized dealer or distributor/ bidder and they should submit latest performance certificate from any other Govt. Hospitals/ Institutions/ PSUs to testify the proper dealing & performance as well as installation and maintenance of equipment.

### 2.14 **INSPECTION OF SUPPLIES**:

Inspection will be done by the duly constituted committee members nominated by Director, AIIMS, Bhubaneswar and or his authorized representatives in AIIMS, Bhubaneswar premises at designated place.

### 2.15 **PAYMENTS**:

- 100% Payment shall be released after successful & satisfactory delivery of the ordered goods against a satisfactory inspection report by the User Department, execution of contract agreement and after submission of Performance Security Deposit by the Supplier/Vendor.
- For processing the payment, the supplier has to submit three copies of Invoice along with receipted challan copy and other relevant papers like Lorry Receipts etc.
- All payments shall be made in Indian Rupees only.

### 2.16 PERFORMANCE SECURITY DEPOSIT:

- 2.16.1 The successful Bidder will be liable to deposit 5% of value of the Contract i.e. value of tentative Five year requirement of Chemical & reagents as Performance Security Deposit in favor of "AIIMS, Bhubaneswar" by way of "Irrevocable Performance Bank Guarantee" or FDR (duly endorsed in favor of AIIMS Bhubaneswar) from a Nationalized /Commercial Bank. These instruments are subject to verification from issuing bank before its acceptance by the authorities.
- 2.16.2 The Performance Security should be valid for 62 months from date of supply, which is refundable after 02 months of expiry of the contract subject to successful fulfilment of terms and conditions and on receipt of requisite "No Dues Certificate" from the concerned Departments /authorities. While making such instruments as PSD, bidders may take care of the period of coverage in the instrument as stated above.
- 2.16.3 The Security Deposit is liable to be forfeited if the bidder withdraws or impairs or derogates the bid in any respect.

### 2.17 **DISPUTES AND ARBITRATION:**

All disputes or differences arising during the execution of the contract shall be resolved by the mutual discussion, failing which the matter will be referred to an Arbitrator who will be appointed by the Director, AIIMS Bhubaneswar for arbitration for settlement of disputes in accordance with Arbitration & Conciliation Act 1996 or its subsequent amendment, whose decision shall be binding on the contracting parties.

### 2.18 LAW GOVERNING THE CONTRACT AND JURISDICTION.

The contract shall be governed under Indian Contract Act 1872 and instructions thereon from the government of India. The Court of Bhubaneswar shall alone have jurisdiction to decide any dispute arising out of or in respect of the contract.

### 2.19 POWER TO IGNORE MINOR DEVIATIONS:

AIIMS, Bhubaneswar reserves right to ignore any trivial nature of deviation(s) in tender documents as decided by the competent authority while processing the tender. The Institute may also seek any clarification/ documents to substantiate the claim of the bidder at the later stage if felt necessary. However, the bidder can't claim it as a matter of right and will be bound to comply the Terms & Conditions of the tender without citing the ground of trivial deviation/ seeking of the clarification/ documents in support of the cancellation of his/ her bid.

### 2.20 **OTHERS**: -

- 2.20.1 After due evaluation of the bid, Institute will award the contract to the responsive Bidder who has quoted Lowest Cumulative Unit Price of all consumables including GST as per Financial Bid (Part-I).
- 2.20.2 At the time of awarding the contract, the tendered quantity can be increased or decreased by 25-30 percent for ordering if so warranted.
- 2.20.3 The Bidder shall not be allowed to transfer, assign, pledge or sub-contract its rights and liabilities under this contract to any other agency(ies) without prior written consent of the Director, AIIMS, Bhubaneswar. If it is found that the firm has given sub-contract to another Agency, the contract shall stand cancelled & the performance security deposit of such Bidder shall be forfeited by AIIMS, Bhubaneswar.
- 2.20.4 The AIIMS Bhubaneswar shall not be responsible for any financial loss or other damage or injury to any item or person deployed/ supplied by the Supplier Agency during the course of their performing the duties to this office in connection with purchase order/ supply order for supplying, installation & commissioning of ordered Equipment/ Accessories/ Items at AIIMS Bhubaneswar.
- 2.20.5 If the bidder denies/ fails to execute the contract/ order after being awarded for the same or to submit the Performance Security, the bid security (EMD) shall be forfeited and the vendor will be debarred for a period of two years from participating in future tenders of the Institute.

# 2.21 Debarment from bidding:

Technical Specifications for Fully Automatic Biochemistry Analyzers on reagent rental basis at Hospital Biochemistry Laboratory

- 1) System:
  - Fully automated, discrete, random-access Biochemistry Analyzer with ISE.
  - Another stand-alone analyzer of the same make and model to be installed as back-up.
  - Both the offered analyzer and the offered reagents should be USFDA/ CE/ ISO/ BIS/ approved.
  - Both analyzers should be brand new. Refurbished analyzer will not be accepted. Supplier must
    provide original documentary proof of the year and place of manufacturing of equipment at the
